

ADDITIONAL NOTES TO THE KNOWLEDGE OF THE MADEIRA BEETLES

ABSTRACT: Corrections and supplements to "Contribution to the knowledge of the Madeira beetles" of 1988 are given.

INTRODUCTION

In our list of Madeiran beetles (ERBER & HINTERSEHER, 1988) unfortunately some specimens had been wrongly identified, so that corrections are necessary. Others had not been identified in time. These and additional material collected by different colleagues which meanwhile has come to hand will be recorded now. The *Ptinidae*, however, can not yet be included, since examining of male copulatory organs in a series of *Sphaericus* specimens showed that more species exist than had been described by WOLLASTON.

As far as possible we will use the same codification as in our paper of 1988, so that corrections in that paper will be easy.

CORRECTIONS

p.155 and 185: *Oligota granaria* ER.

These specimens have been re-examined by S. A. WILLIAMS and were identified by him as *Oligota canariensis* WILLIAMS, 1972. This species had hitherto not been recorded from the Madeira Archipelago (see also ERBER, 1990). The discussion on p. 185 must therefore be erased.

p.157: *Aleochara lindbergi* LIKOV.

The listed specimen from Porto Santo (PS: 5:VIII.85) has erroneously been listed under *A. lindbergi*. It belongs in reality to *Aleochara bipustulata* L., 1761.

p.163 and 195: *Scymnus rubromaculatus* GOEZE

An unfortunate misdetermination: The two listed specimens belong in reality to *Lindorus lophanthae* (BLAISDELL, 1892). (see also ERBER, 1990). The discussion on p.195 must therefore be erased.

p.163/164: *Scymnus interruptus* GOEZE

Unfortunately we overlooked that part of the specimens given under *S. interruptus* belong in reality to *S. levallanti* MULSANT, 1850. The data now given under the latter should therefore be deleted under the former (*S. interruptus*).

p.171: *Apion semivittatum sagittiferum* WOLL.

The specimens from Deserta Grande belong to the subspecies *A. s. semivittatum*.

p.171: *Cathormiocerus viennoti* HOFFM.

Two of the listed specimens belong in reality to *Cathormiocerus curvipes* (WOLLASTON, 1854). Besides this we obtained some more individuals of both species, which will be added here.

p.176 and 203: *Hypothenemus eruditus* WESTW.

Unfortunately a complete misdetermination; corrected record:
